Your next action


- Review the amount you currently give and consider whether you can increase it

- If you have a standing order (or are setting one up) and you pay tax, sign up to Gift Aid using parts 1-3 of the form and bring it back next week or as soon as possible after that.
- If you have any difficulties completing the forms please ask for help

Like any household, our parish has to:


- Cover daily running costs

Looking Ahead

We are already running at an annual deficit. Both St Brigid's and St Paul's Churches are more than 45 years old. There will be major maintenance projects in the coming years that will be necessary in order for the churches to continue to serve this generation and the next.



Standing Order is one of the best ways to support our parish!

A standing order provides the parish with secure, regular income that takes less time and effort to process than loose cash. With fewer of us carrying cash, it offers a straightforward means of giving. And if you are signed up to online banking it is easy to manage.



Methods of Giving 2022 - 2023

To avoid having to find cash each week, set up a standing order using the form provided and bring it back next week. All you need is your bank or building society account number and sort code.

Gift Aid doesn't cost you a penny but helps our parish thrive

It's easy to do and **there's no extra cost to you**. If you have a standing order and you are a UK tax payer, please consider signing up to Gift Aid. The parish can claim an extra 25p for every $\pounds I$ you donate. Last year the parish could have earned up to and extra $\pounds 4,448$ if more people had signed up.
